#### Website Build

##### Client Requirements

**Our team cannot start building the website without the information above.** If these details have been received by our team, there are no other requirements of the client in this step.

**Timeline:** We will deliver your 10-page website within 5 business days from the completion of your onboard call.

**Please note:** Additional add-ons, like additional pages or eCommerce will require additional time. An updated timeline will be provided after the onboarding process is complete.



#### Revisions

##### Client Requirements

Before we set the website live, it's important that the client reviews the entire website to ensure every detail is accurate and meets their needs. It's best to send **1-2** round of major revisions (like changing sections or removing pages) to help streamline the process. We can continue to tweak small revisions after the site is complete or live to ensure you are fully satisfied.

**How it Works:** We will provide you with a preview link to the site along with user access in order to add Site Comments with any notes or revisions that you'd like to see.

**Timeline:** Once revisions are received, we will make the requested adjustments within 5 business days for you to review again.

**Optional:** The client can book a call with a developer to discuss their submitted revisions before we proceed with the work. Revisions will then follow the above delivery timelines based on the received revisions.

Then, once you've had a chance to approve the major changes, we will set the site live within 1 business days (exceptions apply). If you'd like access to edit your site at this time, please let us know and we will update your permissions.

## Process Expectations

In order to build a website your client will love, there are a few requirements that must be met in order to deliver this service efficiently. Please ensure you have read the following for best results.

### Getting Started

There are three components necessary to build a website: hosting, domain, and a template. To understand how each of these pieces relates to your client's website, let's consider an analogy. Let's consider a website as if it was a piece of real estate, like a house.

#### 1. Hosting your Website

If your website is a house, then the hosting is like the land that sits under your property.

For every website we build, we host it directly with Duda. This allows us to manage everything from a single platform - and with a single cost!

#### 2. Choosing a Domain

Using that same analogy, a website domain is kind of the like the address of the house or website.

- **If your customer *doesn't* already have a domain:** There are multiple vendors from which you can purchase a domain, but we recommend [GoDaddy domains](#) as they are the global leader in domains. Specifically, [when you purchase it through the Marketplace](#), you will not need to delegate access or credentials to our team, as we can access it through the platform.
- **If your customer *does* already have a domain:** Clients that already have a domain active can follow these simple steps to share their domain with us.
  - **Option 1:** For GoDaddy, please delegate access to [websites@yourdigitalagents.com](mailto:websites@yourdigitalagents.com).
    - For Google or Squarespace domains, please delegate access to [websitesanalytics@localmarketpage.com](mailto:websitesanalytics@localmarketpage.com).
  - **Option 2:** If option 1 is not possible, please ensure your client shares the following details with us during their onboarding call so that we can access their domain effectively.
    - Provide the URL link to the current domain/website
    - Provide the username and password to get into the domain.

#### 3. Choosing a Template

The last piece of the puzzle is the website template. In our analogy, choosing a website template is like choosing a house blueprint from a developer's collection of showhomes. You are choosing the fixed structure with the opportunity to add final visual touches to make it your own.

You can choose [any two of our recommended templates](#) to mix and match sections as your client desires. Remember to choose a website template based on the aesthetic you feel would best suit your business. Just because a template was initially built for a spa doesn't mean it can't work for your cleaning company.

Here are a few other little odds and ends that you should probably know.

### Service Limitations

If a partner wants to migrate a website from Duda to ours, they must activate the **Accelerated Templated Website product**. Technical teams handle the site transfer from the client's Duda account to ours. We will publish the site and reconnect the custom domain to set the site live.

### Onboarding Call

We can add your Instagram feed into the site using the built-in Photo Gallery module! This will allow us to pull up to 100 images directly from your Instagram account. All other platforms, such as Facebook or X, would require our [Accelerated Templated Website Plus](#) add-on in order to integrate these feeds.

### **Can my client collect payments or donations on their website?**

In order to collect payments on the site via a form, or to accept donations, we would require the [Accelerated Templated Website Plus](#) add-on to be purchased. Our custom form builder allows us to integrate Stripe, PayPal, and Braintree. Donations can be added to the site using Duda's ecommerce, which also allows for Stripe or PayPal.

### **Can I edit my Templated Website myself?**

Absolutely! We limit access to the site until we have completed the website and set the site live on your custom domain. At this time, please let us know if you'd like edit access to your site and we can update your permissions.

Of course! If you provide the credentials or the codes for Google Tag Manager or Google Analytics Manager, we are happy to install it on your client's website.

Yes, unless you have your own Duda account.
